**[PROPOSED] ORDER GRANTING JOINT
STIPULATION TO AMEND THE DEADLINE
FOR PRINTED PUBLICATION NOTICE**

[PROPOSED] ORDER

The Court, having considered the Parties' Joint Stipulation to Amend the Deadline for Printed Publication Notice Set Forth in Paragraphs 19 and 32 of the Preliminary Approval Order, the Declaration of Rochelle J. Teichmiller submitted in support thereof, and the record in this action, and good cause appearing, HEREBY ORDERS as follows:

1. The Joint Stipulation is GRANTED.
2. Paragraph 19 of the Order Certifying Settlement Class, Preliminarily Approving Class Action Settlement, and Approving the Form and Manner of Notice, entered July 28, 2026 (ECF No. 425) (the "Preliminary Approval Order"), is amended to read as follows:

The Short Form Notice, in the form of a Publication Notice, will appear once in the publication *Los Angeles Daily News* on or about August 21, 2026, and once in the *Valley News Group* publications (*Warner Center News*, *Valley Vantage*, and *Calabasas Enterprise*) on or about August 27, 2026.

2 3. The row of the schedule set forth in Paragraph 32 of the Preliminary Approval Order titled
3 “Deadline for publication notice” is amended from “Preliminary Approval Date + 21 days” to “August
4 27, 2026.”

5 4. The Court finds that the Notice Program, as modified by this Order, continues to provide
6 the best notice practicable under the circumstances and complies with the requirements of Rule 23 of the
7 Federal Rules of Civil Procedure and applicable standards of due process. The Court further finds that the
8 delay in print publication was not the result of any act or omission of the Parties or Class Counsel, that it
9 was promptly disclosed, and that no Settlement Class Member is prejudiced by the revised publication
10 dates, which precede the deadlines for opting out, objecting, and submitting claims by a substantial
11 margin.

14 5. The Class Administrator shall address the print publication described in Paragraph 19 as
15 amended in the declaration of due diligence required by Paragraph 25 of the Preliminary Approval Order,
16 and shall attach proof of publication for each publication identified therein.

18 6. Except as expressly modified by this Order, all other terms, dates, deadlines, and provisions
19 of the Preliminary Approval Order remain in full force and effect, including the Final Approval Hearing
20 set for November 12, 2026 at 10:00 a.m. Pacific Time in Courtroom 5B.
